Our Commitment to Children's Privacy

We value the privacy and safety of children. This Children's Privacy Policy explains how we collect, use, and protect personal information from children under the age of 12 in accordance with the **Children's Online Privacy Protection Act (COPPA)**.

We do **not** knowingly collect personal information from a child without first obtaining verifiable parental consent.

If parental consent is not received, the child will not be registered in the Kids' Club and no personal information will be retained.

Information We Collect

A child may visit our website and view content without providing personal information.

If a parent or legal guardian registers a child for the Monaco Modified Kids' Club, we may collect:

Parent/Guardian Information

- Parent/Guardian full name
- Email address
- Mailing address
- Phone number

Child Information

- Child's first and last name
- Birth date (to verify age and birthday recognition)
- Favorite driver (optional)
- T-shirt size (optional)

We collect only the information reasonably necessary for participation in the Kids' Club.

How We Use the Information

We use the collected information solely for internal purposes, including:

- Confirming Kids' Club membership
- Sending welcome materials and club merchandise
- Birthday recognition
- Kids' Club activities and giveaways
- Event notifications and family promotions
- Contest participation and winner notification

We **do not sell, rent, or trade children's personal information** to third parties.

Parental Consent

A parent or legal guardian must complete the registration and provide consent before a child becomes a member of the Monaco Modified Kids' Club.

If consent is denied or withdrawn:

- The child will not be enrolled
- Any collected information will be deleted

Parents may request confirmation of membership after registration.

Information Sharing

We do not share children's personal information except when necessary to operate the Kids' Club, such as:

- Mailing merchandise or prizes
- Processing contest awards
- Service providers assisting with website operations

These providers are permitted to use the information **only** to support Monaco Modified Kids' Club operations.

We may also disclose information if required by law, legal process, or public safety investigation.

Security of Information

We take reasonable precautions to protect personal information using physical, electronic, and administrative safeguards to prevent unauthorized access or disclosure.

Parental Rights

At any time, a parent or guardian may:

- Review the personal information we have collected
- Request corrections
- Request deletion of information
- Withdraw consent
